APPLICATION

Directions for use:

It is a violation of federal law to use this product in a manner inconsistent with its labeling. Surfaces to be painted or stained must be clean, dry, sound and free of existing mildew. The dispenser is calibrated so that when fully pressed down, it will release sufficient mildewcide to treat one (1) gallon of paint. To treat a five (5) gallon of paint, the dispenser will need to be fully pressed down and released five (5) times, and so on. Shake or stir thoroughly, then use paint as directed. Note that this dispenser provides effective protection for normal painted surfaces. For extremely damp areas prone to mildew, two (2) pumps for 1 gallon or ten (10) pumps for 5 gallons should be used. **NOTE: Do not use for any paint applications involving direct or indirect food or drinking water contact.**

Storage and Disposal:

Do not contaminate water, food or feed by storage or disposal.
STORAGE: Store product in a cool, dry place out of the reach of children.
PESTICIDE DISPOSAL: Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.
